Applewood Community, or its agent agrees to maintain the above requested services on an "as needed" basis. Snow will		
be removed when there is an accumulation of 3 inches or more.		
This agreement is not valid or binding until payment is made and the contract is signed and approved.		
In the event of a snow emergency/blizzard/major "noreaster", you will be plowed as soon as we can and as fast as		
we can. On those days, we ask for your patience. If there is a state of emergency in Oneida County and travel is banned,		
you will be plowed as soon as possible. Contracted "early" customersyou may not be reached by your early time in rare cases of blizzards/noreasters/states of emergency, etc.		
Applewood Community, or its agent is NOT responsible for any reflectors, driveway paint/sealant, landscape timbers,		
decorative ornaments, etc., that may be lining, parallel or adjacent to the driveway. Please arrange for removal of all		
driveway obstacles prior to the snow removal season. Also, Applewood is not responsible for moving parked cars. Thanks!		
If you feel that you were missed, please know it is never intentional. Mistakes happen! If you feel that everyone else on		
your street was plowed except for you, it was simply a mistake. Please call the office, report it immediately and accept our		
apology. The crew will return to you asap!! Thanks for your patience!
